The **Front Line Cash Handling training** is a new development providing one-hour and forty-five-minutes of online training designed for anyone in a treasury office or at locations throughout an organization who handles cash. We also continue to offer our in-depth **Cash Handling training** which includes the core material as well as best practices to minimize risk and enhance security while processing transactions. **Internal Controls training** is offered in two parts - one and a half hours each on an introduction to internal controls and implementing internal controls. The training and networking agenda of our **Annual Conference** combines all our training topics and interests into a packed three days. We’re so grateful to our committee and Utah partners for what is going to be a fantastic 2023 conference for both in-person and online attendees.

**Certified Public Funds Investment Manager (CPFIM) training** is designed to provide the confidence and knowledge to manage your investments better. And there is also an Advanced CPFIM certification that focuses on analysis and investment strategy and how to quantify investment policy objectives. The CPFIM training was launched 16 years ago and continues to be a sought after certification. To make sure everyone stays current, these certifications are renewed every five years.

I am honored to have served as the APT US&C President and I thank you for the amazing opportunity. I hope you enjoy perusing the following pages to stay updated on what your Association has focused on over the last year - I know the Board has worked very hard to provide you with high quality and high value learning opportunities that we’re all proud of. 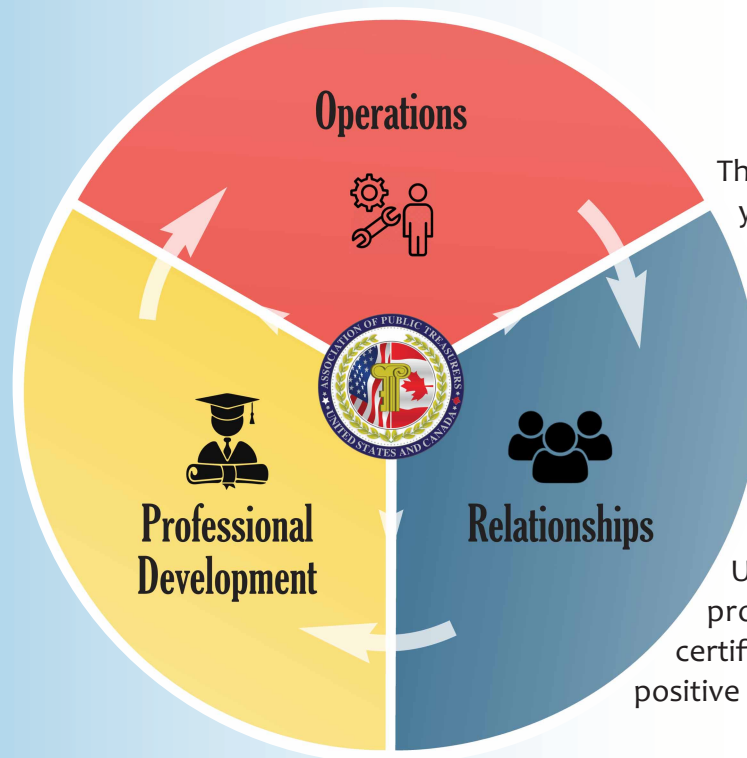
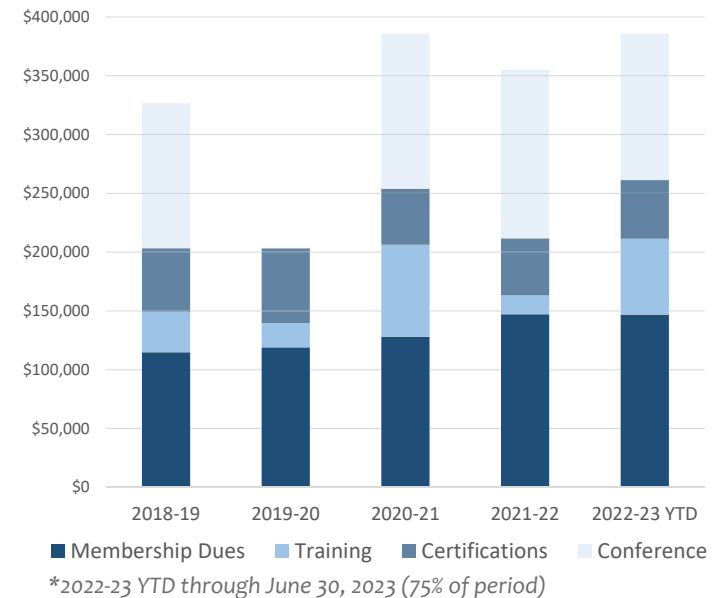

# A COMMITMENT TO TRAINING

APT US&C proudly offers training courses to assist public treasury professionals and their staff. APT trainers typically provide sessions online for convenience, but training can also be provided on-site or as part of a conference. Online training is livestreamed and interactive through Q&A and chat functions. Manuals are also available for Cash Handling, Internal Controls, and Cash Flow Forecasting. Training sessions are offered regularly and are always posted online at [www.APTUSC.org](http://www.APTUSC.org). Members receive a registration discount.

**Front Line Cash Handling** training is for cash handlers to understand the responsibilities and risks of accepting payments and processing transactions for an organization. Attendees learn best practices for accepting all forms of payment, identifying counterfeit currency, the importance of customer service, and minimizing risk and enhancing security.

**Cash Handling** training is an in-depth session that includes the material in the Front Line Cash Handling training but also goes deeper into the hows and whys that managers need to know to properly handle an organization's cash transactions.

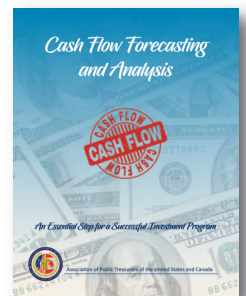
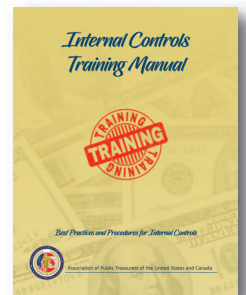
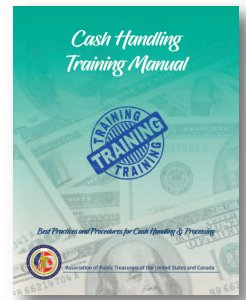
**Introduction to Internal Controls** investigates internal controls for cash handling, budgeting, HR, payroll, and more. A one-and-a-half hour training designed to explore operational procedures throughout an organization to provide an introduction to internal controls for anyone who handles cash or provides support to treasury/finance departments.

**Implementing Internal Controls** training is intended for managers who are responsible for cash receipting and ensuring the safety of an organization's assets. Training explains how internal controls should permeate all functional areas of an organization and that without internal controls, an organization has a much higher risk for fraud and loss. Training investigates how to mitigate risk through internal controls.

# CERTIFIED PUBLIC FUNDS INVESTMENT MANAGER

The nationally recognized Certified Public Funds Investment Manager (CPFIM) certification program is designed to provide the confidence and knowledge to manage investments better. Attendees learn about: Investment Instruments; Banks, Brokers & Advisors; Cash Flow; Governance & Your Investment Policy; Safety, Liquidity & Yield; and Defining Your Strategy.

Graduates of the CPFIM training can take their understanding further with the Advanced CPFIM training. With a deep look into Analysis and Investment Strategy, attendees gain a more thorough knowledge of how to quantify an investment policy objective and the tools needed to achieve it.

The CPFIM training was launched in 2007 and in 2011 the program expanded to offer the Advanced CPFIM. Both programs are offered online and occasionally in-person. Both the CPFIM and ACPFIM must be renewed every five years. A recertification class is available for those who are due to recertify.

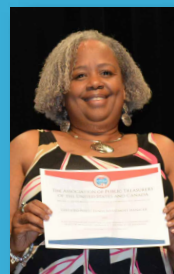
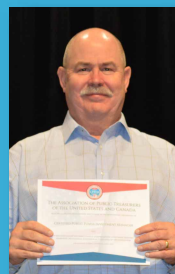
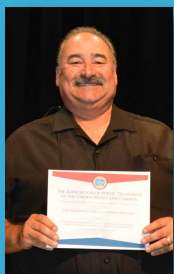

# CERTIFIED PUBLIC FINANCE ADMINISTRATOR

APT US&C's Institute Training Program guidelines are for state organizations who want to provide their members with a comprehensive plan to develop the building blocks and core skills that every treasury professional should have. It is designed to allow State Associations to work in tandem with APT US&C to ensure that a complete curriculum is provided to their attendees. This also makes it easy for applicants who have graduated from approved State programs to apply for the Certified Public Finance Administrator (CPFA) or Advanced Certified Public Finance Administrator (ACPFA) accreditation.

The Institute training program is designed to be offered annually over a three year period. In addition, states may offer an annual maintenance or advanced level of instruction for members to attend who have already completed their initial three year training program. Advanced level training may qualify for Advanced CPFA certification.

This program is a serious commitment for treasury professionals to further their knowledge and improve themselves professionally. The program is structured to incorporate a minimum of 100 education hours over the three-year period. Ninety-four hours are in Public Finance Administration and Professional Development and six hours are peer knowledge sharing throughout training.

The Certified Public Finance Administrator (CPFA) and Advanced CPFA certifications are distinguished national credentials for treasury professionals who achieve excellence in public treasury standards. Both credentials demonstrate a dedication to education, public treasury experience, leadership, and a commitment to strengthening the treasury profession.

The CPFA and ACPFA are intended for treasury professionals and applicants must be committed to ethical behavior as defined in the guidelines of APT US&C's Code of Ethics.

An initial CPFA certification requires a combined total of 100 points earned through experience and education. To achieve the Advanced CPFA certification, applicants must hold a current CPFA certification, maintain active and continuous APT US&C membership since their last certification, and demonstrate a combined total of 60 points earned through experience and advanced continuing education. Applicants are expected to be involved in leadership roles within state or national treasury organizations.

APT US&C's Investment Policy Program provides public investors with guidance and technical assistance in developing a comprehensive written investment policy. The Association's Model Investment Policy includes the essential elements and provides an outline for treasury officials to use to develop their own policy.

Policies submitted for certification are reviewed on the eighteen areas specified in the model policy. The policies that attain these certification standards demonstrate an adherence to professional standards established to ensure prudent management of public funds.
